

#### How the Board Works

The Board meets at least four times a year during office hours, and meetings are held in person at our Bristol office\*. These sessions provide vital space for oversight, decision-making, and strategic direction. In addition to the main Board meetings, Trustees actively contribute through sub-committees and short-term working groups, which focus on key areas of ASDAN's operations and development. These currently include:

- Performance, Audit, Risk and Compliance
- People and Development
- RISE (Responsibility, Inclusion, Safeguarding and Ethics)
- Digital Learning Platform (working group)

Beyond formal governance duties, Trustees are encouraged to engage meaningfully in the wider life of the organisation. This includes attending ASDAN events, supporting strategic initiatives, and connecting with our staff, partners, and learners.

An annual away day brings Trustees and senior leaders together for deeper strategic reflection, long-term planning, and teambuilding, ensuring alignment and shared vision for the future.
